



Armen Ashmat Hakobyan was born on March 18, 1976, in Yerevan.

In 1998, he graduated with honors from the Yerevan State Institute of National Economy, majoring in "Accounting and Auditing". He continued his education at the postgraduate course of the same university and, defending his PhD thesis in 2001, received a PhD in economics.

In 2004, by the decision of the scientific council of the Yerevan State Institute of National Economics, he received the scientific title of associate professor.

In July 2012, defended his doctoral dissertation on the topic "Renting: problems of accounting and financial management in the Republic of Armenia", and by the decision of the Professional Council of the Higher Qualification Commission of the Republic of Armenia, Armen Hakobyan was awarded the scientific degree of Doctor of Economics.

In December 2019, he received the scientific title of professor.

Since 1998, he has been teaching "Accounting in banks", "Financial accounting" and other professional subjects at the Armenian State University of Economics. Armen Hakobyan is a member of the ASUE 014 Economic Council, as well as the author of more than 60 scientific articles, manuals and monographs on Accounting and Finance.

According to the certificates issued by the Central Bank of the Republic of Armenia, he has the right to work in the positions of chief accountant, deputy chief accountant, investment fund manager and foreign fund manager.

He has participated in various training courses in RA, Lebanon, Netherlands, Czech Republic, France and Great Britain.

From 19.05.1998, he worked in "ACBA BANK cooperative, now "Acba bank" OJSC, holding the following positions:

From 13.12.2006 to 27.02.2007, he was the Acting Chief Accountant at "ACBA-CREDIT AGRICOLE BANK" CJSC, from 27.02.2007 to 20.07.2015, he was the Deputy Chief Accountant.

From 08.01.2014 to 09.02.2016, worked at "AMUNDI-ACBA ASSET MANAGEMENT" CJSC, holding the position of Chief Accountant.

From 20.07.2015, Armen Hakobyan was appointed the Chief Accountant at "Acba bank" OJSC.

He is a member of the RA Chamber of Accountants and Auditors, has a qualification certificate as an expert accountant, and is a member of the chamber's qualification committee.
